Lodges should give careful consideration to their membership structure and attempt to send a balanced delegation, reflective of the different companies and/or classifications within the Lodge. Of course, the Lodge's finances and applicable bylaws will need to be considered since all expenses of the delegates will be borne by their respective Lodge.

The enclosed Delegate Form should be completed and returned to this office by each Local Lodge Recording Secretary at the earliest opportunity, **but no later than May 1, 2011**. This is extremely important because we will need to know the number of delegates and representatives attending so that committee assignments can be made, and to provide ample notice of committee assignments to the Lodges in advance of the Conference.
