### Euthanasia for Old War Horses

Dick Lugar saw his six-term career in the United States Senate come to a screeching end last month. Orrin Hatch faces a contested primary later this month, and his challenger is a Tea-Party favorite similar to the candidate who put Lugar out to pasture. Lugar and Hatch were icons of the Republican Party in the 1970s and 1980s. Both had been Senate committee chairmen – Foreign Affairs for Lugar (R-IN) and Judiciary for Hatch (R-UT). Lugar was roundly trounced by a Tea Party-backed candidate, and Hatch could be the next victim.

The Grand Old Party is euthanizing its old war horses. And its Tea Party activists are the ones sticking pentobarbital-filled needles in their backs.

Lugar joins Senators Bob Bennett

(R-UT) and Mike Castle (R-DE) and Governor Charlie Christ (R-FL), who were put down by Tea Party challengers in 2010.

Remember Christine O'Donnell, the "witch" from Wilmington? While unsuccessful in holding on to Castle's seat in the general election, she was part of a grassroots movement that still curses all GOP incumbents. And those curses are backed up by big money.

Both the movement – and its money – reach far beyond state lines. In Indiana, seven groups spent a total of \$2.9 million to defeat Lugar. Only one of them was actually based in the Hoosier State. Hatch's opponent is also getting big bucks in outside contributions.

Euthanizing old war horses intimidates every GOP member of Congress. Before casting a vote or taking a position, a Senator or Representative must first check in with the powersthat-be. Of course, that's not the voters who sent them to Washington, but the Club for Growth and the Heritage Action for America, two anti-government, conservative bully groups.

"What we are watching is absolutely appalling," explained IAM International President Tom Buffenbarger. "Lugar was a hard-core, anti-union Senator. But I take no pleasure in seeing him put out of his misery. At least he and some of the old GOP war horses recognized the need to work with members of the other party on some issues for the good of the nation.

"What comes next could be even worse. They could be replaced by anti-union extremists, who will seek to revoke our rights to strike and bargain collectively."

The defeat of Lugar and the primary challenge to Hatch gives more worker-friendly candidates – Democratic Congressman Joe Donnelly in Indiana and former State Senator

Scott Howell in Utah – a chance to flip those seats. And yet, hanging in the balance is Democratic control of the United States Senate.

The battle for Senate control keeps intensifying.

As the respected <u>Cook Political</u> <u>Report</u> notes, 13 states either lean Democratic or are considered too close to call. A net loss of four Democratic seats would give Senator Mitch McConnell (R-KY) and GOP antiworker extremists total control over the agenda and floor actions in the next Congress.

The only way to stop that from happening is for working families to play an active role in the November elections. Register to vote. Volunteer for labor walks and telethons. Visit campaign headquarters and ask for yard signs. And remember to "like" and "share" what the <u>IAM</u> and <u>UCubed</u> post on their Facebook pages.

The GOP's old war horses may be a dying breed. But if working families don't get riled up and ready to fight, then those anti-union extremists may start needling the American labor movement.

## Documentary Exposes Koch Brothers' Election Agenda

When the conservative majority on the Supreme Court issued its 2010 landmark decision in *Citizens United vs. Federal Election Commission*, election laws were fundamentally changed to allow almost unlimited independent spending in the nation's elections.

As the result in the Gov. Scott Walker recall election in Wisconsin shows, the enormous amount of independent spending by conservative groups can overwhelm traditional grassroots efforts that are the hallmark of labor's strength in elections.

Two of the biggest players in conservative spending are the billionaire Koch brothers, a bastion of extreme right-wing funding for conservative

and anti-union candidates. A new documentary film, produced by director Robert Greenwald, uncovers the socioeconomic and environmental influence peddling by Charles and David Koch (pronounced "coke").

Koch Brothers Exposed details the brothers' relentless and stomach-turning efforts to undermine the interests of working-class Americans on issues ranging from Social Security to the environment to civil rights.

"The Kochs are willing to use hundreds of millions to attempt to buy de-

mocracy on a grand scale," said Greenwald in a recent interview. "The use of their enormous resources is driving our country towards greater and greater economic and power inequity."

Koch Industries, the second largest privately-owned company in the United States, currently bankrolls a vast network of members of Congress, state lawmakers and conservative organizations. Their most recent actions include funding the aggressive, wide-scale effort to roll back U.S. voting laws in an attempt to suppress the minority, elderly and young vote. The Koch brothers have pledged to spend roughly \$1 billion in an effort to unseat President Barack Obama. And they continuously fight any environmental regulation that could potentially subtract from their bottom line.

"It is important we use all the tools at our disposal to investigate and expose. And most important, to take action," says Greenwald. "Get the film. Host a screening. Tell your friends." The Kochs are willing to use hundreds of millions to attempt to buy democracy on a grand scale."

## Alan Simpson Goes Ballistic on California Seniors

Former U.S. Senator Alan Simpson (R-WY) makes a strong case for anger-management medication with a letter he fired off to the California Alliance for Retired Americans (CARA) over the group's opposition to Simpson's proposals to cut Social Security benefits.

Unleashing a torrent of abuse, Simpson attacked CARA members for a campaign flyer designed to highlight the importance of Social Security for future generations.

"You use the faces of young people, who are the ones who are going to get gutted while you continue to push out your blather and drivel," railed Simpson in the letter dated April 7, 2012. "What a wretched bunch of seniors you must be to use the faces of the very people that we are trying to save, while the 'greedy geezers' like you use them as a tool and a front for your nefarious bunch of crap."

The letter, which quickly went viral on the Internet, is in keeping with an earlier Simpson rant, in which he described Social Security as "a milk cow with 310 million tits."

As co-chairman of the National

Commission on Fiscal Responsibility and Reform, Simpson has drawn the ire of seniors nationwide with proposals to lower the deficit by raising the retirement age to 69 and lowering cost-of-living adjustments for retirees.

According to the Social Security Administration, increasing the retirement age from 67 to 69 represents a 13 percent benefit cut on top of the 13 percent cut already made when the retirement age was increased from 65 to 67. Overall, the proposals endorsed by Simpson would cut retirement benefits by as much as 36 percent for young people

entering the workforce today.

Social Security provides the majority of income for twothirds of the nation's elderly; for one-third, it provides nearly all their income. The average "greedy geezer" that Simpson criticizes gets about \$1,125 per month, or about \$13,500 per year. To a lot of American workers who were not fortunate enough to belong to a union, or who, like Simpson, have spent almost 40 years in public service at taxpayers' expense and have a healthy pension, Social Security is most of what many survive on in retirement.

# Drastic Transportation Cuts Voted Down in the House

Common sense in Congress actually prevailed, for a change, as transportation funding survived an attack by extreme right-wing opponents. The U.S. House of Representatives voted down a motion by Rep. Paul Broun (R-GA) to cut \$17 billion from mass transit and highway funding.

Broun tried to insert his misguided

motion into H.R. 4348 – the Surface Transportation Extension Act of 2012. If it had passed, billions in funding of mass transit and highway projects would have been cut, causing devastating job losses in the transit and highway sectors and crippling our nation's transportation system.

The AFL-CIO Transportation Trades Department, of which TCU is a member, sent letters to every member of the House requesting that they vote "no" on the Broun motion. Even most of his fellow Republicans thought the extreme idea was misguided, and the motion was defeated by a vote of just 83 "For" and 323 "Against."

Broun's motion would have put a limit on Highway Trust Fund spending, including the Mass Transit Account. These cuts would likely prevent any new investments, halt job creation and bring economic growth in the transportation industry to a standstill.

Our surface transportation system

desperately needs an infusion of federal investments but the Broun motion went in the opposite direction – it would have devastated our transportation system, harmed the economy and put hundreds of thousands of men and women out of work.

"We at TCU are pleased to see this motion defeated," said TCU President Bob Scardelletti. "We will continue to insist that Congress complete a surface transportation bill that will maintain our members' jobs and create more."

### SkillsUSA, a Partnership for the Next Generation



For more than ten years, Local 701 Training Program Director Louie Longhi has helped run the automotive segment of the SkillsUSA competition that promotes skills training for America's youth.

Louie Longhi knows the importance of skills training and preparing America's youth for the economic future.

As Program Director and Lead Instructor for IAM Local 701's Education and Training Program outside Chicago, Longhi has helped run the automotive segment of the Illinois SkillsUSA Competition for more than ten years. He himself has been involved with SkillsUSA more than 16 years.

"It's about promoting the vocational trades and keeping them alive in our schools," says Longhi. "I've been teaching automotive for 20 years. Yes, manufacturing has been going overseas, but there are certain trades that can't go anywhere.

Cars still need to be fixed. You can't ship them out to fix them. Carpenters still need to build things here like houses. Plumbers, bricklayers, nail technicians, hairstylists, police officers, fire-







men – these are jobs that can't be shipped away. If we don't start training the next generation, where are they going to come from?"

SkillsUSA is a partnership of students, teachers, labor and industry professionals working together to ensure America has a skilled workforce. It serves more than 300,000 students and instructors annually in all 50 states, the District of Columbia, Puerto Rico, the Virgin Islands and Guam.

Each year thousands of high school and post-secondary career and technical students in the Illinois SkillsUSA Chapter travel to Springfield for real hands-on experience, an opportunity to showcase their talent and compete in their respective areas. Contests continue through the national and world levels. Judges and contest organizers from labor and management make the event possible.

### NLRB 'Mole' Resigns Over Ethics Charge


A pair of investigative reports from the Inspector General (IG) of the National Labor Relations Board (NLRB) highlight the blatant hypocrisy of the Republican attacks on the integrity of the NLRB. The IG reports detailed the unethical behavior of Republican Board member Terence Flynn, who resigned in July.

While Flynn was serving as chief counsel to another Republican Board member, Flynn was giving confidential Board information to influential Republican critics, including Peter Schaumber, a top advisor to Mitt Romney's presidential campaign. The IG reports found that Flynn leaked confidential details on the status of pending cases; divulged

how board members planned to vote on specific cases and leaked the board's internal strategy for handling legal cases brought against it.

Flynn was leaking confidential information at a time when the NLRB was under intense right-wing criticism for enforcing laws protecting the rights of workers, including the high-profile case against the Boeing company for improper retaliation against IAM members who went on strike in 2008.

The first IG report, released in March, concluded that Flynn released "deliberative, predecisional information" on pending Board rulings to former NLRB member Peter Schaumber. At the time, Schaumber was a top labor policy advi-

sor to Republican presidential candidate Mitt Romney. Romney made attacks on the NLRB a key part of his campaign to secure the GOP presidential nomination.

The IG report also concluded that Flynn improperly leaked internal documents to Peter Kirsanow, a former Republican NLRB board member and attorney for the pro-business National Association of Manufacturers (NAM).

The organized attacks against the NLRB included GOP presidential candidates who attacked the NLRB's decision on Boeing. GOP members of Congress tried to gut the board's funding and strip it of enforcement authority. And the right-wing spin machine which accused the board of being biased toward labor.

The second IG report detailed numerous communications between Flynn and Schaumber, including efforts by Flynn to assist Schaumber with editorials that were critical of the board's activities on behalf of workers represented by labor unions.

In a Sept. 6, 2011 editorial published in the "National Review," Schaumber claimed the NLRB is heavily biased in favor of the rights of working people and that labor unions may no longer even be necessary.

Less than a week after the "National Review" editorial was published, Romney named Schaumber as co-chairman of the campaign's labor policy advisory group. Schaumber resigned his position with the Romney campaign shortly after the leaks became public.

In addition to the two reports from the board's Inspector General, the case has been referred to the U.S. Justice Department as a possible breach of the Hatch Act, which prohibits federal employees from engaging in partisan political activity while on duty.
