

# TCU/ARASA 5101Lodge Meeting

He shall handle grievances of members within the Local in accordance with the procedure Section 17 prescribed in Article 12 of these Statutes. He is also charged with the duties to see that all laws, rules, regulations, and directives, of the National Union, are strictly enforced. He shall cooperate fully with National Union Officers in enforcing agreements. He shall keep the members of the Local fully informed on matters of legislative interest to the Union and to carry out the instructions of the National Legislative Director and the National President concerning these legislative issues. He shall perform such other duties as are prescribed in the National Union Constitution or By-Laws of the Local.”

President Dennis Deyo then turned the meeting over to the Chairman of the Board of Trustees, Ken Willard to report on nominations. Bother Willard reported that 3 nominations and acceptances by the nominee were received by mail,
